- 1) Update on Guidance from Steering Committee
  - a) Whatever we do needs to be addressing poverty: What actions can we take? (not just elder/disabled adult issues but focus on those persons providing care to elder/disabled adults)
  - b) Also need to address racial disparities:
    - i) 98 white, 106 black, 1 Hispanic= Elders in Services in A-C county
    - ii) most live alone
    - iii) 60% of those served are at or below poverty (125% of the poverty rate)
    - iv) Once senior center per county but transportation services provide county-wide access
- 2) What have we learned about existing services?
  - a) Also need to focus on Caregiver. How?
    - i) Care-net (through Roselyn Carter Institute—local contact through AAA)
    - ii) What caregivers need?
      - (1) Waiting list for services: homemaker, home delivered meals, respite

This could increase their income by getting them better jobs, and address poverty issues in A-C County on multiple levels.
